

Dear Friends,

The N.H. Preservation Alliance's past year was full of successes in saving special places, advancing public policy, and expanding our base of support. Citizens Bank recognized our effectiveness with their Champion in Action® award for Neighborhood Development. Calls for service continue to climb as many families, non-profit property owners and developers look to us for creative solutions to preservation challenges.

We're fortunate to work with preservation champions all over the state every day. We have engaged 37% more people in our activities than we had the prior year, and had our best annual fund ever. The map on the cover and the rest of this report should give you a sense of how we customize services for varied situations, and how a little help can propel a preservation project forward over time.

Here is one of our favorite recent stories: Daniel Avers of Northumberland secured one of our barn assessment grants three years ago. He had purchased his "fantastic place" to preserve the land and buildings which were such an integral part of town history. His landmark property stands across from the 1799 Meeting House, is on the site of Fort Wentworth and the old muster grounds, had been owned by the same family for five generations and was part of an old stage coach stop. With the road map for stabilization and repair of his 1880s barn that our grant provided, he is not only preserving the barn, but this year, he "paid it forward" by giving the Alliance the amount of his grant to support our activities and help other barn owners.

Not everyone's story is like Dan's, but your involvement with the Preservation Alliance is vitally important so we can continue to find new uses for historic properties, stimulate local investment, create jobs, inspire ongoing community development activities and provide assistance and outreach throughout the state.

Your renewed support and on-going suggestions are important to us as we face the preservation challenges that lie ahead. We look forward to continuing to work together, investing in people and communities, to meet the state's preservation needs.

Saving Special Places

Thirty percent of our *Seven to Save* endangered properties moved off the list this year, and our consitutent contacts for these projects consistently gave high marks to the Preservation Alliance for the direct assistance they received. We also served over 100 community projects, including 57 on-site coaching visits and 12 planning grants as shown on our map, and assisted thousands of property owners at events, by phone and through the internet. In a survey this spring, 71% of our constituents reported they know more about preservation than they did a year ago, and 85% of those attributed the change in knowledge and behavior to the Preservation Alliance.

Strengthening Preservation Policy

The Preservation Alliance worked with legislators to establish three new tools this year that will help property owners, preservation investors and community groups protect and revive historic resources. SB 80 allows municipalities the option to offer property tax relief for certain qualified investments in properties on or eligible for the State or National Register of Historic Places. SB 43 recognizes the important role played by small, historically-significant retail properties in our communities and allows municipalities to provide property tax relief to them. SB 12 authorizes municipalities to adopt optional provisions for protecting or preserving archaeological resources in master plans, subdivision regulations and site plan review regulations. The use of several existing tools like the tax incentive that encourages barn preservation also saw gains this past year.
