Hall of Flags, NH Statehouse, Concord
Battle flags returned from the Civil War form the nucleus of this memorial hall's collections.
Concerns are mounting that the flags are deteriorating and action is needed by legislators to ensure their long-term preservation.

Pickering House, Wolfeboro. A gateway to the downtown and at risk from years of deferred maintenance, this well-known landmark was the home of a leading businessman and now contains 5 apartments. ### Rye Town Hall
